The entire deposit will be refunded to bona fide Bidders upon the return of the Documents, in good condition to Action Reprographics, within thirty (30) days after the Bid Opening. A separate \$25.00 non-refundable check made out to Beeline + Blue must accompany the deposits for each set to be shipped. Members of Associated Builders and Contractors of Iowa may obtain Bidding Documents by use of the non-cash security method adopted by the ABC of Iowa. Members of Master Builders of Iowa may obtain Bidding Documents by use of the non-cash security method adopted by the Master Builders of Iowa, Inc. Bid shall be addressed to Kate Baldwin, Business Manager of the Norwalk Community School District and delivered, to the location and room noted in the first paragraph of this document, in sealed envelopes marked with the Project Name, Bidder's name and Bid Package Number. Bid Forms shall be sealed in a separate envelope from the Bid Security and marked "Bid Form" along with the Bidder's Name, Project Name, Bid Package Number and Owner's Name on the outside. with the See Section 00 2113 Instruction to Bidders for additional information. Any alteration of the Bid Form may be cause for rejection of the bid. Each bid shall be accompanied by a bid bond, certified check, cashier's check or certified credit union share draft in a separate envelope in the amount equal to five percent (5%) of the total amount of the bid. The certified check or cashier's check or certified share draft shall be drawn on a bank or credit union in Iowa or a bank or credit union chartered under the laws of the United States of America, and payable to the Norwalk Community School District as security that if awarded a contract by resolution of the Board, the Bidder will enter into a contract at the prices bid and furnish the required performance and payment bonds and certificate of insurance. Failure to follow these specific bidding instructions as outlined in this notice or the bid documents may be cause for rejection of the bid.

The certified check, cashier's check, or certified share draft may be cashed, or the bid bond forfeited, and the proceeds retained as penalty if the Bidder fails to execute a contract or file acceptable performance and payment bonds or provide an acceptable certificate of insurance within ten (10) days after the acceptance of his or her proposal by resolution of the Board.

Bids will be required to be submitted under a condition of irrevocability for a period of thirty (30) days after the date set for the opening bids. Bid Alternates shall remain valid for the period for the duration stated on the bid form.

Bids will be received under separate contracts as outlined in the bid-package descriptions listed above. Bids will only be accepted for the above listed bid packages. Separate contracts will be awarded for each Bid Package, and no tied bids will be permitted.

Payment of the cost of the project will be made in cash from such fund or funds of the School District as may be lawfully used for said purpose.

By virtue of statutory authority, preference will be given to products and provisions grown and/or produced within the State of Iowa, and preference will be given to Iowa domestic labor as provided in the Code of Iowa.

The Owner reserves the right to reject any or all Bids and to waive informalities or irregularities in the bidding.
